# About this document

- Between 24<sup>th</sup> July and 2<sup>nd</sup> August 2018 the Improving Healthcare Together programme held 6 discussion events, 2 in each of the CCG areas it covers: Surrey Downs, Merton and Sutton. - As well as this record Traverse will produce an independent report which summarises what was said which will be shared with everyone who attended the events, as well as being published on the programme website.




